but it is also peak football season. As a die-hard college football fan (go Vols!), I know the frustration of seeing referees interfere with a good game. While their role is crucial in protecting the players and maintain-

ing fairness, sometimes their calls can disrupt the flow and distract from the experience. I find the Environmental Protection Agency's (EPA) new regulations on power plants similarly upsetting.

The EPA has introduced new rules targeting existing coal and new natural gas power plants, requiring them to drastically reduce their output or implement carbon capture and storage (CCS) technology. While CCS could theoretically reduce greenhouse gas emissions,

it's an unproven and costly technology. No utility in the country has successfully implemented CCS at the scale the EPA is demanding.

The result? Higher costs, which will lead to increased power bills for all of us. Given our growing population and economy, the need for reliable energy for all of South Carolina is crucial. Extreme winter temperatures highlight the importance of maintaining a robust electric grid. Renewable energy sources, such as solar farms, can help meet that need. But they aren't always available, especially on

cold winter mornings and evenings when the sun isn't shining.

To keep up, we will need to be able to rely on 24/7 energy sources, including natural gas and, at least for now, coal. Yet the EPA seems intent on throwing its vellow flag and ejecting those reliable power plants from the game. That's why we are actively working alongside other electric cooperatives to challenge these regulations in court and in Congress.

A big part of our current and future success comes from the support of our state lawmakers who continue to keep

> the needs of cooperatives and their members in mind. Their support is essential in ensuring that we can continue to provide you with reliable, affordable electricity. You'll find them listed on page 5.
