# Rate adjustment to address rising costs

AS A MEMBER-OWNED, notfor-profit cooperative, Aiken Electric Cooperative operates solely to serve you, our

members. Our commitment has always been to deliver dependable power at the lowest possible cost, and we know that any change to our electricity rate impacts your household.

After exhausting every possible option to avoid this step, we have reached a point where an adjustment is necessary. To continue delivering essential services while accounting for rising costs in our industry, a rate adjustment will take effect in January 2025. I'd like to explain why.

## Why is this rate adjustment necessary?

Over the past five years, we've seen the price of critical materials, equipment and supplies double. Wholesale power costs also have risen dramatically.

Because South Carolina cooperatives like ours purchase electricity from suppliers such as Duke Energy, Santee Cooper and the Southeastern Power Administration, our rates are driven in large part by the price of wholesale power from those suppliers.

Those wholesale prices are going up. In particular, we will see significant cost increases arise due to the end of a court-agreed Santee Cooper rate freeze on Dec. 31, 2024.

Starting in 2025, Santee Cooper customers-including co-op members-will begin paying for the unbudgeted, extra costs that Santee Cooper incurred during its rate freeze period, when the utility wasn't allowed to raise its rates to cover those costs.

We don't yet know exactly how much co-op members will have to pay for these new costs, but we expect it to be substantial—into the hundreds of millions of dollars. These charges will come on top of Santee Cooper's other planned rate increases, which will help it meet the rising

prices for fuel and materials.

As a not-for-profit cooperative, we don't want to raise our electric rates any more than you do, but these rising supply and wholesale power costs are beyond our ability to absorb.

## What does this mean for you?

Below you will find a chart detailing our new residential rate. The specific impact will vary depending on your household's energy usage. We recognize how inflation continues to strain daily budgets, and this rate adjustment was not made lightly. We're making this change as a last resort after months of careful analysis and consideration.

# **AEC Annual Meeting** May 16-17

THE 87TH ANNUAL MEETING of Aiken Electric Cooperative will be held at 2790 Wagener Road in Aiken on Friday, May 16, 7 a.m.-7 p.m., and Saturday, May 17, 7 a.m.-12:30 p.m. The business meeting will be held virtually and streamed on the cooperative's Facebook page.

In addition, one proposed bylaw amendment will be on the ballot:

## **ARTICLE IV - TRUSTEES**

### Section 4. Qualifications

(d) The Board of Trustees is authorized to adopt a policy requiring all candidates for Board Trustee positions to disclose campaign donations, relationships with all nonmembers and/or non-member organizations, conflict of interests to the business interest of the Cooperative, and/or a statement of economic interests. Such disclosures shall be on forms as adopted by the Board of Trustees and shall be available to the membership of the Cooperative for inspection. A policy so adopted may contain a requirement that failure to make the required disclosures in a timely

manner will be cause for disqualification of a candidate and/or if a candidate is elected without making accurate disclosures such as Trustee can be removed for cause from the Board upon a majority vote of the Board of Trustees.

What you need to know This amendment allows the Board to require Trustee candidates to disclose campaign donations, conflicts of interest and economic interests. Disclosures will be on board-approved forms and will be accessible to cooperative members. Failure to disclose may disqualify a candidate or result in removal if elected. This amendment is an addition and does not change any existing bylaw provisions.

## Fun on the farm

Sara's Farm Adventure stays connected with high-speed internet

SARA'S FARM ADVENTURE is more than just a farm—it's a family-friendly outdoor park packed with fun for all ages. The new agritourism park in Trenton, opened in September, offers hayrides, corn mazes, a petting zoo, light shows, food trucks, live concerts and more. Designed with families in mind, Sara's Farm Adventure is built around one simple idea: to provide a fun, educational space for the community to enjoy together.

To make it all happen, they're using high-speed internet service from CarolinaConnect.
